WAIVER AND RELEASE OF LIABILITY

HOT AIR BALLOON FLIGHT OR TETHER

In consideration of the Baxley-Applying County Chamber of Commerce, Applying County Board of Commissioners, Baxley Tree Fest DBA Bicentennial Festival, furnishing services and /or equipment to enable me to participate in the Hot Air Balloon flight event, I agree as follows:

I fully understand and acknowledge that outdoor recreational activities have (a) inherent risks, dangers and hazards and such exists in my participation of Applying County Bicentennial Festival / Hot Air Balloon activities; (b) my participation in such activities and/or use of such equipment may result in injury or illness including but not limited to bodily injury, disease, sprains, fractures, partial and/or total paralysis, or other ailments that could cause serious disability or death; (c) these risks and dangers may be caused by the negligence of the Baxley-Applying County Chamber of Commerce, Applying County Board of Commissioners, Baxley Tree Fest DBA Bicentennial Festival employees, officers, agents or volunteers of Baxley-Applying County Chamber of Commerce, Applying County Board of Commissioners, Baxley Tree Fest DBA Bicentennial Festival; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, pilot decision making, including that a pilot may misjudge terrain, weather, risks of falling out, and such other risks, hazards and dangers that are integral to recreational activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the Baxley-Applying County Chamber of Commerce, Applying County Board of Commissioners, Baxley Tree Fest DBA Bicentennial Festival, employees, officers, agents or volunteers of the Baxley-Applying County Chamber of Commerce, Applying County Board of Commissioners, Baxley Tree Fest DBA Bicentennial Festival, or by any other person.

I, on behalf of my personal representatives, my heirs, and myself hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Baxley-Applying County Chamber of Commerce, Applying County Board of Commissioners, Baxley Tree Fest DBA Bicentennial Festival and its employees, officers, agents or volunteers from any and all claims which may arise out of my participation in Bicentennial Festival activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the Baxley-Applying County Chamber of Commerce, Applying County Board of Commissioners, Baxley Tree Fest DBA Bicentennial Festival, employees officers, agents or volunteers of the Baxley-Applying County Chamber of Commerce, Applying County Board of Commissioners, Baxley Tree Fest DBA Bicentennial Festival.

The venue of any dispute that may arise out of this agreement otherwise between the parties to which the Baxley-Applying County Chamber of Commerce, Applying County Board of Commissioners, Baxley Tree Fest DBA Bicentennial Festival, or its agents is a party shall be either the Applying County Courthouse in the City of Baxley, Applying County, Georgia, or State Supreme Court in Atlanta, Ga.
