The Chamber's Annual Legislative Update was held last week. Mayor Skip Campbell moderated the breakfast and members were able to hear directly from Senator Lauren Book, Parkland Mayor Christine Hunschofsky as well as Coconut Creek Mayor Josh Rydell, Coral Springs Vice Mayor Lou Cimaglia and Commissioner Dan Daley. Some of the issues that were covered included Home Rule, the opioid crisis, medical marijuana and the Marjory Stoneman Douglas Act. Many of you

know that the legislature passed this act quickly, however, the problem is that the legislature did not provide funding for it.

Our School Action Safety Committee has made school safety a high priority and at the last meeting, we had guest speaker Cindy Seltzer, CEO of Children's Service Council of Broward County, as well as Mayor Hunschofsky. We collaborated to find venues that can host continued mental health counseling for students from all schools, with the immediate focus on this summer. The Chamber will be getting the word out and serve as a resource to be the connector between required needs and our business members.

Additionally, in May, the Chamber hosted the Annual Education breakfast sponsored by Broward College. We heard from students from seven local high schools and I know we were all in awe regarding the talent of these students. The Chamber provided over \$5000 for the business clubs of the local high schools to support their future endeavors.
