Release, Indemnification and Hold Harmless Agreement

In consideration of participation in Future Angler of Minnesota (FAM), outdoor activities or any activity sanctioned or affiliated with FAM, I hereby agree to release and discharge from liability arising from negligence Future Anglers of Minnesota, and its owners, directors, officers, employees, agents, volunteers, participants, and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees"), on behalf of FAM or myself and my children, parents, heirs, assigns, personal representatives and estate, and also agree to the following:

1. I acknowledge that the activities that I am engaged in with FAM, involve unanticipated risks which could result physical or emotional injury, paralysis or permanent disability, death, or property damage. Risks include, but are not limited to, death or serious injury as a result of being hurt due to equipment malfunction; hearing loss; loss of vision; broken bones, bruises and other bodily injuries caused by falls; medical conditions resulting from physical activity, and damaged clothing or other property. I understand such risks simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity.
2. I expressly accept and assume all the risks inherent in this activity or that might have been caused by the negligence of the Releasees. My participation in this activity is purely voluntary and I elect to participate despite the risks. In addition, if anytime I believe that event conditions are unsafe or that I am unable to participate due to physical or medical conditions, then I will immediately discontinue participation.
3. I hereby voluntarily, release, forever discharge, and agree to indemnify and hold harmless Releasees from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity, or my use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releasees or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
4. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or damage myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks created, directly or indirectly, by any such condition.

5. I agree that FAM and its persons operating under their control may ask for dismissal of my participation and I will agree to do so.

6. I agree that if any portion of this agreement is found to be voided or unenforceable, the remaining portions shall remain in full force of effect.

By signing this document, I agree that if I am hurt or my property is damaged during my participation in this activity, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim or negligence.
