- **1. Pomme de Terre Report** Groneberg had a handout on the Pomme de Terre JPB Budget vs Actual through March 31<sup>st</sup>, 2014. Board discussed. A 319 grant has been applied for in the Pomme de Terre. They also have \$150,000 for incentives for permanent buffers and Grant SWCD had 5 applications in that area but BWSR didn't approve any of them at the state level.

- **3.** One Watershed / One Plan—The Grant SWCD's Water Plan was adopted as the Comprehensive Plan for the District and Expires December 31, 2015. Board discussed. Motion was made by Christenson, seconded by Groneberg to request and extension from BWSR and the County Commissioners until we know more on the One Watershed / One Plan. - **4. RIM Update**—Olson had 6 applications in the targeted area and only 1 of those got accepted from BWSR. We will re-submit the other ones in the next funding cycle if the landowners are still interested.
- **5.** NRCS Report—Mosburg reported that he has been working on CSP and EQIP contracts and the local work group met to set local priorities for EQIP. Dally went along with Gulbrandson for a couple of mornings to do CRP status reviews.
