Groneberg cast a unanimous ballot to elect Larson to the office of Chairman, seconded by Dally. Larson is the Chairman.

Motion was made by Dally, seconded by Groneberg to elect Christenson to the office of **Treasurer.** Affirmative: Larson, Groneberg and Dally. Opposed: None. Motion Carried.

Motion was made by Groneberg, seconded by Larson to elect Dally to the office of **Personnel Director.** Affirmative: Larson, Groneberg and Dally. Opposed: None. Motion Carried.

- 2. **Pomme de Terre Report**—Groneberg had a handout of the Grant Funding for the Pomme de Terre CWF.
- 3. **Conservation Lands Summary / CRP Update**—Handouts of BWSR's Conservation Lands Statewide Summary was discussed. Gulbrandson had a handout with maps of the CRP in Grant County. Board discussed.
- 4. **NRCS Staffing Update**—Sean Johnson (Milaca) will be the acting District Conservationist for Grant County NRCS.

- 5. Mustinka/Bois de Sioux One Watershed/One Plan Update—Board discussed the One Watershed/One Plan and the options of a LGU being the grantee or forming a JPB. House has been the coordinator through the application period. The group met last Monday and the LGU's agreed to pay for House's time for that period. Motion was made by Groneberg, seconded by Dally that Grant SWCD will not be the Grantee for this grant. Affirmative: Larson, Groneberg and Dally. Opposed: None. Motion Carried. Motion was made by Groneberg, seconded by Dally that Grant SWCD is in favor of pursing a Joint Powers Board at this time. Affirmative: Larson, Groneberg and Dally. Opposed: None. Motion Carried.
- 6. **Chippewa River One Watershed/One Plan & JPB Update**—Board discussed and will continue to pursue One Watershed/One Plan in the Chippewa River Watershed. The Chippewa currently has a JPB but it does not include SWCD's at this time.
- 7. **Authorize Montonye to sign CWF and 319 Projects**—Motion was made by Groneberg, seconded by Dally to allow Montonye to sign CWF & 319 projects as needed. Affirmative: Larson, Groneberg and Dally. Opposed: None. Motion Carried.
- 8. **Area I Envirothon Donation Request**—Motion was made by Dally, seconded by Groneberg to donate \$300.00 to the Area I Envirothon. Affirmative: Larson, Groneberg and Dally. Opposed: None. Motion Carried.
- 9. **2018 Area I Dues**—Motion was made by Dally, seconded by Groneberg to pay the 2018 Area I dues in the amount of \$150.00. Affirmative: Larson, Groneberg and Dally. Opposed: None. Motion Carried.
- 10. **2018 MASWCD Dues**—Motion was made by Groneberg, seconded by Dally to pay the 2018 MASWCD dues in the amount of \$2,520.79. Affirmative: Larson, Groneberg and Dally. Opposed: None. Motion Carried.
- 11. **Designate Depository for District Funds--**Motion was made by Groneberg, seconded by Larson to continue with the checking and savings accounts at Bank of the West in Elbow Lake and to continue to shop around when purchasing a certificate of deposit for the best interest rate as they mature. - **12. Mileage Rates and Supervisor Compensation Rates--**Motion was made by Dally, seconded by Groneberg to use the IRS standard mileage rate of \$.54½/mile for supervisors and staff for 2018 and continue to pay supervisor compensation at a rate of \$75.00/day (the maximum). Affirmative: Larson, Groneberg and Dally. Opposed: None. Motion Carried
