- 3. Approve Pomme de Ter3re Conservation Practice Assistance Contract (2016 Federal 319 Grant) Rollofson Children's Trust—Motion was made by Groneberg, seconded by Dally to approve contract #26-04-16-319 for Rollofson Children's Trust for Multi-species cover crop in the amount of \$15,2000.00 for the total practice Cost Estimate for all 5 years. Approve State Cost-Share Assistance Contract Timothy Boys**—Motion was made by Groneberg, seconded by Dally to approve the State Cost-Share Contract for Timothy Boys in the amount of \$2,802.25 for a critical area planting with cost-share not to exceed 75% in the amount of \$2,101.69. Approve State Cost-Share Assistance Contract Jody Kruize**—Motion was made by Groneberg, seconded by Dally to approve the State Cost-Share Contract for Jody Kruize in the amount of \$6,732.50 for a critical area planting and field windbreak with cost-share not to exceed 75% in the amount of \$5,050.00. Approve FY2018 & FY2019 State Cost-Share Grant Amendment**—Motion was made by Dally, seconded by Groneberg to approve the FY2018 & FY2019 Cost-Share Grant Amendment expiration date from December 31, 2020 to December 31<sup>st</sup>, 2021. - 7. Pomme de Terre Report Groneberg—There were public meetings in Morris and Dalton that were not well attended to get comments from the public on the 1W1P for the Pomme de Terre Comprehensive Plan. Comments are being worked on from the public and agencies. Groneberg also had a Grant Funding Summary showing the money available from each grant.
