

Suicide Prevention 5 Things You Should Know

Suicide is a leading cause of death among workingage adults in the United States. It deeply impacts workers, families, and communities. Fortunately, like other workplace fatalities, suicides can be prevented. Below are 5 things to know about preventing suicide.



Everyone can help prevent suicide.

Mental health and suicide can be difficult to talk about–especially with work colleagues—but your actions can make a difference. When you work closely with others, you may sense when something is wrong.

PAY ATTENTION

Know the warning signs of suicide.

There is no single cause for suicide but there are warning signs. Changes in behavior, mood, or even what they say may signal someone is at risk. Take these signs seriously. It could save a life.



REACH OUT

Ask "Are you okay?"

If you are concerned about a coworker, talk with them privately, and listen without judgment. Encourage them to reach out to your Employee Assistance Program (EAP), the human resources (HR) department, or a mental health professional.



TAKE ACTION

If someone is in crisis, stay with them and get help.

If you believe a coworker is at immediate risk of suicide, stay with them until you can get further help. Contact emergency services or the National Suicide Prevention Lifeline.

MO VALLEY JATC NEWS & UPDATES CONT.

NFWS-

Beginning the week of January 30th 2023, line apprentices will be able to earn hot time at class while working on our Local 160 Timpson system's. This has been authorized by the board of trustee's. I will use this quarters news letter to give some information and possibly answer a few questions that may arise.

Q: So what is the Timpson System?

A: The Timpson System is tool that has brought our training to another level. We are able to have full system voltage on our distribution circuits at class with no arc flash or fault current hazard. In the past we have done a lot of "mock" hot activities. There is a time and a place for those exercises, but it's difficult to pretend something is energized when it is not. One of the best ways to think of it, is as a giant GFCI. It uses 120/208 3-phase secondary voltage to back feed dry core transformers up to the primary voltage we want on the circuit. If there is a phase to phase or a phase to ground contact, it trips the system and notifies us. The relaying monitors the current on the line and when it changes by more than 3 milliamps it starts to cycle and open. It opens in milliseconds and typically at a threshold of 10 milliamps over-current or less. As a safety measure the entire system total line current is capped at 30 milliamps. This is what allows us to use the trainer at class safely.

Q: How are we using it?

A: We currently have 3 in use at class. A 12.4KV overhead system, a 12.4KV URD system, and a 4KV overhead system. We have a 25KV overhead system as well and are in the works of building that line. For the last 9 months we have been using the Timpson with hot apprentices at class. We have specific tasks that we teach, practice and then evaluate the apprentices on over the course of the program. We call these hands on exercises Performance Assessment Tasks or "PAT's" for short. The idea behind these PAT's is that we have a way to now verify and track an apprentices individual-field related knowledge, performance and skill set, to make sure they are where the field wants them to be. They must pass these task's in addition to their work books in order to move to their next step as an apprentice.

Q: What are some of the expectations?

A: Apprentices will be monitored by an instructor, who is a Journeyman Lineman at all times while they are working on the energized Timpson. Each 4 man crew will have a designated foreman, pair of "lineman" in the air, and an observer. They will all be evaluated on how they perform each role as they rotate through. They will be responsible for setting up equipment, tool selection, tail board and task execution (aloft and on the ground).

Q: Why are apprentices allowed to work together on energized lines while at class but not in the field?

A: Great question. I reiterate that the Timpson allows us to energize lines to full system voltage at class. HOWEVER, we do NOT have any arc flash, or fault current exposure like a true power line does. This allows us to put them in the position to plan and work the tasks at class and think and act and perform the roles of a journeyman that they will soon be. That is why, while inside the fenced boundary's at class, our apprentices are allowed to work together in the air with out a Journeyman Lineman in the same elevation. In addition, this is covered in depth and documented at class, before an apprentice is allowed to be on the system.

I would like to wrap this letter up with a thank you to local 160. While in the building process a few years ago, Local 160 made 2 large donations to Mo Valley. The second large donation came from the desire to sponsor the Timpson Trainer. The members of the local voted to make the donations and in turn, basically covered the cost of the Timpson. Being able to energize circuits to full system voltage and stop with the "mock" activities for the high steps, has changed the way we have been able to train and takes it to a new level.
