Format:

- 5 player/15 games
- Handicap
 - 10 points max per round
 - 5 is the minimum average used
 - Will be established on night 1 of play. After your matches are done simply add up your points for your 3 games and divide by 3 to get your average to use. This method will also be used for subs.
EX. 8 4 6 = 18 18 / 3 = 6 So my average is a 6
- Blind Score will also be used in the event of being short a payer. The blind score to be used is a 4 per game for player that is gone, opponent will receive a 10 per game.

Length of season/days off

- We will play 2 full rounds
- Days off are as follows:
 - December 25th
 - January 1st

Envelope collection procedures

- Visiting team is to drop them off the night of play at the following locations:
 - Shoes Pub
 - The Market
- Late fee of \$10 will be assessed on late score sheets/monies
- Cash Only

Player Fees:

- Weekly player fees \$5.00/person
