## IMPORTANT LEAGUE NOTES & INFORMATION

**Player Sanctions:** Captains packets will be outfit will sanction slips. On the first night of pool, I need each player to fill out slip and insert with scoresheet. Any NEW Player to a roster MUST Fill a slip out and enter it into the envelope. **THIS GOES FOR ALL PLAYERS THE FIRST NIGHT OF LEAGUE—OR THE FIRST NIGHT THEY SUB IN A LEAGUE OUTSIDE THEIR REGULAR NIGHT.** Dues will still be taken at the end of the year, but this will help in identifying which teams players want sanction fees taken from.

**Player Rankings:** Player Rankings will be based primarily on CompuSport's Power Ranking Formula applied to every eligible player in all leagues. The Formula was applied to everyone in all leagues to find ranking "Tiers" within the MCC League Base. Players individual power rankings them identify which tier they should be placed in. Exemptions will be made and a finalized rankings list will be produced after ranking "committee" meets to evaluate power ranking results sometime this fall.

**The Power Ranking Formula is:**

$$((\text{Total Score}/2) + (\text{wins} *3) + (10-0 \text{ wins} *2) + (\text{ERO} *4))$$

----- = Power Ranking

**League Liaison:** The League Liaison was elected by the league members who attended the league meeting. This individual will:

- Be the Primary Point of Contact to handle all league questions/disputes.  
**\*NOTE: Unless liaison is directly involved in question/dispute, contact MCC office.**
- Represent your league alongside all other league liaisons when they meet to evaluate CompuSport's Power Ranking Formula and to suggest/make adjustments as needed to individual player ranks thereof.

**League Format/Scheduling:** Your Format is: 5 Player, 25 Game Format.

**NO SUBS MAY BE ADDED AFTER Dec. 1<sup>st</sup>, 2018.**

- 10 Shooters MAX on Roster
- Your League has Elected to do one full round robin with 18 teams, then split the league into two groups of 9 teams and do another full round robin ending the regular season on Apr. 18<sup>th</sup>.
- If amount of teams is unequal, the last place team in any position round week will receive AVG 8-Ball Points & AVG Round Wins based on their season statistics.

**Playoffs:** Your league has elected to have playoffs.

- TEAMS MUST "OPT-IN" BY INDICATING ON A PLAYOFF PARTICIPATION SHEET WHICH WILL BE MADE AVAILABLE ONE MONTH IN ADVANCE OF REGULAR SEASON.
  - Teams "opting-in" will NOT BE MADE PUBLIC.
- All teams will be in one playoff bracket. Seedings will be determined by finish position in respective division after second round robin is complete. (I.E.: If all 18 teams went to playoffs, the best team in the lower division would be the 9<sup>th</sup> place seed in the bracket)
- The First two weeks of playoffs will be shot across the bar locations with the loser side of the bracket shooting on a day in advance of the following Thursday so to keep pace with the Winners side of the playoff bracket. After two weeks of this are complete, remaining teams will finish on a Saturday at a location TBD.

**League Money:** Your league has elected to pay back to do payback's as following:

Teams OPTING-IN to playoffs: 70% 8-Ball Points, 30% goes to playoffs.

Teams NOT PARTICIPATING in Playoffs: 100% 8-ball points.
