IMPORTANT LEAGUE NOTES & INFORMATION

Player Sanctions: Captains packets will be outfit will sanction slips. On the first night of pool, I need each player to fill out slip and insert with scoresheet. Any NEW Player to a roster MUST Fill a slip out and enter it into the envelope. **THIS GOES FOR ALL PLAYERS THE FIRST NIGHT OF LEAGUE—OR THE FIRST NIGHT THEY SUB IN A LEAGUE OUTSIDE THEIR REGULAR NIGHT.** Dues will still be taken at the end of the year and only to players who are eligible (12 Games) but this will help in identifying which teams players want sanction fees taken from.

Player Rankings: Player Rankings will be based primarily on CompuSport's Power Ranking Formula applied to every eligible player in all leagues. The Formula was applied to everyone in all leagues to find ranking "Tiers" within the MCC League Base. Players individual power rankings them identify which tier they should be placed in. Exemptions will be made and a finalized rankings list will be produced after ranking "committee" meets to evaluate power ranking results sometime this fall.

The Power Ranking Formula is:

$$((\text{Total Score}/2) + (\text{wins} *3) + (10-0 \text{ wins} *2) + (\text{ERO} *4))$$

----- = Power Ranking

League Liaison: The League Liaison was elected by the league members who attended the league meeting. This individual will:

- **Be the Primary Point of Contact to handle all league questions/disputes.**

League Format/Scheduling: Your Format is: 4 Player, 16 Game Format.

NO SUBS MAY BE ADDED AFTER Dec 1st, 2018.

WE ARE TRYING ROTATING SUBS IN YOUR LEAGUE THIS SEASON! This means rostered players can shoot for other teams than their own in the event that team needs a sub. YOU WILL BE RESPONSIBLE FOR FIGURING A PLAYERS HANDICAP BY REVIEWING STANDINGS SHEET!

- Your League elected to complete a schedule that consists of three (3) total round robins with a position round at the conclusion of the first two round robins.
 - **EXISTING PLAYERS USE LAST YEARS AVERAGE FOR FIRST 8 GAMES SHOT.**
 - **New players enter league with an 8 AVG (Men) or 6 AVG (Women) AND WILL USE THAT AVERAGE FOR THEIR FIRST 8 GAMES SHOT.**
 - **LOWEST AVG USED IN LEAGUE WILL BE A 6 FOR ANY PLAYER.**
 - **IF A ROSTER HAS A VACANT SPOT: THAT VACANT SPOT WILL BE FILLED USING THE OF THE PLAYER WHO HAS THE MOST GAMES SHOT FROM THE TEAM THAT IS SHORT A PLAYER. IF TWO PLAYERS ON SAID TEAM EQUAL MOST GAMES SHOT, THE HIGHER AVERAGE PLAYER WILL BE USED.**
- If amount of teams is unequal, the last place team in any position round week will receive AVG 8-Ball Points & AVG Round Wins based on their season statistics.
 - **PLEASE NOTIFY OPPOSING TEAM IF YOUR TEAM WILL BE RUNNING LATE- COMMUNICATION IS KEY!**

Playoffs: Your league has elected to have playoffs.

- All teams will advance to playoffs.
- Playoffs will be shot out on Monday with HIGH SEED HOSTING the match.

League Money: Your league has elected to pay back to do payback's as following: 70% 8-Ball Points, 30% goes to playoffs.
