We are pleased to announce that Northwell Health will return as the official sponsor of the 23rd Annual Village of New Hyde Park Street Fair. If you want an announcement made during the Fair, please complete and submit the Announcement Card prior to the Street Fair. Announcements will be made in late morning and mid-afternoon.

To ensure the safety of pedestrians, merchants, Village employees, and Fair organizers, we are limiting vehicular access onto Jericho Turnpike. You will not have vehicular access onto Jericho Turnpike to set up in the morning or to close down in the evening. To access your sidewalk space, please drive to the closest intersection, park your vehicle, and then unpack. Please do not attempt to access Jericho Turnpike via Herkomer Street because this street will be utilized by Craft-A-Fair vendors only. **Please make sure your team understands this directive, especially if you assign others to set up or break down. It is your responsibility to ensure your entire team knows how to properly access their sidewalk space.**

The Nassau County Police and New Hyde Park Fire Department require that the street alongside the curb line remain open and accessible for emergency vehicles. **Therefore, your table/display must remain on the sidewalk and not in the street.** Please keep in mind that sidewalk space is limited so it's important that you respond as quickly as possible. We ask your help in promoting the Street Fair. Please copy, display, and distribute the enclosed promotional material to your customers. We look forward to celebrating the 23rd Annual Village of New Hyde Park Street Fair with you.
