

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://oakhavenmassage.com/>, and Oak Haven Massage and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Oak Haven Massage include <https://oakhavenmassage.com/> and Oak Haven Massage. The Oak Haven Massage website is a Business Information site. By using the Oak Haven Massage website, you consent to the data practices described in this statement.

Privacy Compliance Certification

Oak Haven Massage has PCI compliance certification.

Collection of your Personal Information

In order to better provide you with products and services offered, Oak Haven Massage may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Oak Haven Massage's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Oak Haven Massage may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. - SSL Protocol

- Comply with the California Electronic Communications Privacy Act;
