Participants are responsible for supplying a challenge for teams (Maximum 25 teams of 2 which involves up to 50 racers).

SET UP: Participants will set up at their place of business and welcome teams as they arrive. They will instruct teams on the challenge to be completed in order to receive the clue (provided by hosts) to continue their race.

The team who completes all challenges (10) and returns to Columbus Park first will receive the grand prize of \$1000 Cash.

THE AMAZING RACE SPRUCE GROVE 2018 AGREEMENT

BETWEEN: THE SPRUCE GROVE & DISTRICT CHAMBER OF COMMERCE (hereafter referred to as "the chamber")

AND: _____ ("the participant")

IN CONSIDERATION of the mutual covenants contained in this Agreement, the parties agree as follows:

1. The chamber shall permit the participant to be a part of the race clues, pit stop/road block challenge where up to 50 participants will arrive at their place of business, complete a challenge and receive their next clue before leaving the premises.

2. Pit Stop/Road Block: The vendor agrees to pay the sum of \$250.00 to support the prize package, advertising, and post event recognition/advertising of the challenge according to the enclosed cost schedule.

GST is additional to all prices in the cost schedule. The Spruce Grove & District Chamber of Commerce GST Number – 10800 0910 RT0001

3. To fully comply with the terms and conditions set forth in the contract between the participant and the chamber.

4. To observe and abide by all rules and directives of race management including procedures and further the municipal law as it may apply to the participant.

5. Not to assign or transfer the contract.

6. To have a representative in attendance at the pit stop/road block challenge location during all times until notified of final team competition.

7. To comply with all valid federal, provincial and municipal legislation, regulations, by-laws, resolutions and standards including, without restricting the generality of the foregoing, maintenance of insurance in such amounts and for such coverage as is required by any federal, provincial or municipal regulators or licensors of the Exhibitor's business.

8. Food and concession spaces require local health board and fire department permits and must conform to all applicable regulations. All intended food samples or products must be approved by The Spruce Grove & District Chamber of Commerce.

9. To provide the show management with completed documentation required by the contract including confirmation of comprehensive general liability and non-owned automobile insurance coverage in the form of a Certificate of Insurance.

10. The vendor shall indemnify the management, its employees, directors, officers, agents, volunteers and the City of Spruce Grove, and hold them harmless from and against all liability, claims, damages or expenses which shall include, but, not be limited to any and all costs in enforcing this agreement, including legal fees on a solicitor client basis, for or arising out of nay act or neglect by the exhibitor, its servants, employees, agents, invitees, licensees in and about the event premises.

****Participants will be required to sign a waiver indemnifying all road block/pit stop participants from and against all liability, claims, damages or expenses which shall include, but, not be limited to any and all costs in enforcing this agreement, including legal fees on a solicitor client basis, for or arising out of nay act or neglect by the exhibitor, its servants, employees, agents, invitees, licensees in and about the event premises****

11. Failure to comply with regulations may result in removal from the race, forfeiture of all fees paid and or termination of the contract.

12. Event will take place regardless of the weather conditions. No refunds will be issued due to adverse weather. Please consider adverse weather when creating challenge.

13. Cancellation Policy: In consideration of the race planning, deposits are non-refundable. After September 1st, no refund will be forwarded on full \$250 participation fee. The nature of the race involves careful planning to ensure smooth transition for both participants and race teams between pit stops and roadblocks.
