Just announced 10/13/20:

As announced last Thursday on the LBC President's call, the USA Boxing Board of Directors approved a 10% discount **for non-athletes and clubs** registering **between 11/1 – 12/31/2020**. Non-Athlete and Club fees will return to normal price on 1/1/2021.

2021 Registration: Early registration for 2021 begins November 1st 2020. The USA National office as well as Local LBC #30 will **NOT** be raising registration fees this year.

Latest news for Officials (posted by USA Boxing National office 10/27/20)

Hello Officials,

The R/J Commission of USA Boxing has approved a virtual online refresher course that will extend an Officials certification to December 31, 2021.

Level I, II and III Officials, whose certification will expire before Dec 31, 2021, should take advantage of this opportunity. We understand some LBCs are in different phases of the Back to Boxing roadmap and not able to host "In-person" clinics. This will give those officials a stress reliever knowing when they return to boxing, their certification is still up to date. We asked the Chief of Officials in each LBC to host clinics at their test events and are happy to see that happening. Continue reaching out to them and ask when a clinic will be held in your LBC.

Officials attending this virtual refresher course can expect a short, but comprehensive presentation on Judging and Referee mechanics, lasting 3 hours. By clicking [HERE](#), you will fill out a questionnaire, asking you to choose the date and time of the clinic you choose to attend. The dates listed are arranged by time zone, please adjust accordingly. You will receive a link to the class, 48 hours prior to the "Zoom" meeting. Please fill out all the information listed and act quickly, classes begin Nov.6.

Again, your attendance to this course will only **EXTEND** your certification till Dec 31, 2021. As this is not a certification clinic, no elevation of certification will be given. Only Officials whose certification is current, that will expire before Dec 31, 2021 or may have lapsed since March 2020, will be allowed to attend.
